- Video production to enhance technical skills, such as filming and editing, to include critical thinking, problemsolving, and communication skills to enhance digital literacy;
- Video production, to provide teaching strategies for students to create documentaries, news reports, short films, and multimedia presentations that capture understanding of subject matter; in a compelling and dynamic way.
 - Examples: news or feature packages, man on the street polls (broadcast journalism), promotional videos (advertising), and short films (filmmaking), creating PSAs for the school or other related activities Podcasting and livestreaming events but not limited to.
- Pre-production (planning, scriptwriting, storyboarding, location scouting, storyboards);
- Production (cameral work/ camera angles, lighting, audio, and various filming techniques);
- Post-production (media management, content editing, visual and sound effects, and delivery)
