Please refer to our <u>Invitation for Bid No. 014-2025 Outright Purchase of Two-Way Radios and Accessories</u>, a copy of which was obtained by your company for consideration.

Please see written questions submitted by Protective Bidder(s), with GDOE response below:

JMI Healthcare Systems, Inc.

1. We respectfully request clarification regarding the bid specifications for IFB 014-2025 Outright Purchase of Two-Way Radios and Accessories, which reference a specific model of two-way radios. During the pre-bid conference, it was noted by Ms. Tricia Rosario that no "or equivalent" will be accepted.

GDOE RESPONSE: There is a determination to file that was done prior to this solicitation for these reasons: GDOE currently uses Motorola equipment and is requesting the continued use of this brand to ensure compatibility with existing equipment, accessories, and replacement parts. This approach also promotes uniformity across the department and alignment with the Guam Police Department (GPD) frequency.

Pursuant to 2 GAR §3109 — Determinations and Findings, a written determination and findings (D&F) shall be prepared

and approved prior to the solicitation when required by regulation, to document the facts and rationale supporting the procurement decision.

- 2. Kindly confirm whether the specification is intended to be strictly brand-specific, or if equivalent models that meet the required performance and technical characteristics may also be considered.
 - For reference, Guam Procurement Law provides: 5 GCA § 5268(b): A brand/model may not be specified unless a written determination establishes that its features are essential.

We therefore seek confirmation as to whether this procurement has been formally justified as brand-specific, or whether "or equivalent" offers will be acceptable.

GDOE RESPONSE: Yes, this is a brand-named procurement, Pursuant to 2 GAR Div.4 §4103(b)(2)(c) - Need brand name specification because only the identified brand name will satisfy the territory's need.

3. In addition, we respectfully request that your office provide a reference to the communication system of the Guam Police Department (GPD) with which these two-way radios will be linked, for our information and proper evaluation.

GDOE RESPONSE: The system that connects to GPD is called "Smartnet."

4. Furthermore, may we also request that the bid submission deadline be extended by two (2) weeks from the original due date, to allow sufficient time for vendors to prepare and comply.

GDOE RESPONSE: We have no objection to extending the bid submission deadline by two (2) weeks.
